- Choreographers must FULLY complete the Entry Forms including membership or transaction ID for paid membership. Our preference is transaction ID. But Membership numbers are also acceptable.
- All entries should reach us through our [Performance Registration Portal](#). Any other means such as verbal, email or phone entries will not be accepted.
- If you are a life time or 5-year Member or 2024 Annual Member and can't find your IANT Membership number then please contact info@iant.org
- All Participants can renew or apply for membership at <http://www.iant.org>. Registration will be considered incomplete, if proof of valid membership is not available on the entry form.
- Sending an registration portal entry form is not an automatic acceptance to perform at India Day. Entries will be confirmed by the India Day committee upon verification of data.
- Solo performances will not be accepted. Each performance must have a minimum 8 participants with a maximum of 20 participants including choreographers and assistants.
- Each performance can have a single Choreographer and an assistant if needed; An additional assistant can be added to the team, if there are more than 12 participants in a performance.
- No performer will be allowed to participate in more than one performance.



13. Minimum age to participate is Five (6) years at the time of submission.
14. Due to the nature of the program, no live vocal or music for dance performances will be accepted. Only pre-recorded audio recordings will be accepted as background music for the performance.
15. Each performance cannot exceed 5 minutes.
16. Repetition of songs in performances is not allowed. Similar performances will be selected on a 'First-Come-First served' basis.
17. We encourage themes that are fast paced Folk, Regional, Patriotic, Semi-classical and Movie song performances appropriate for the family event.
18. Dance schools submitting multiple entries must have each performance submitted in a different theme.
19. Performers are not allowed to wear glass accessories or use props that can shatter, break or leave residue on the floor, e.g. trinkets, jewelry that can break easily. No stickers, tapes or markers on stage.
20. All participants, including Choreographers and their assistant(s) will be given complimentary non-transferrable wristband/entry-pass to attend India Day. Their complimentary seats will be reserved in a particular section.
21. All Participants who want to sit outside of their reserved section before/after their performance, must buy tickets
22. All participants will be provided complimentary beverages and snacks after their performance.
23. All participants must report to the back-stage coordinator on the event day at the Venue by their specified reporting time
24. For a smooth flow of the INDIA DAY program, your cooperation is highly appreciated.
25. IANT's decision will be deemed final in all contingency situations.
